
Dear Amir ji

The Multi sectoral Development Programme (MsDP) is being implemented in identified 75 Blocks and 8 towns of 20 districts of Bihar, as an area development initiative to address the development deficits of minority concentration areas by creating socio-economic infrastructure and providing basic amenities. The guidelines of MsDP provide for involvement of community in monitoring and assessment of the programme through an appropriate mechanism of Social Audit.

A Joint Task Force of Ministry of Panchayati Raj and Ministry of Rural Development along with this Ministry on "Expanding the scope of Social Audit" has decided to include MsDP, inter-alia, in a bouquet of Centrally Sponsored Schemes for which a Social Audit has to be carried out. It has been decided by the Joint Task Force to do a pilot Social Audit of MsDP in Kishanganj District of Bihar. The pilot shall be carried out by National Institute of Rural Development, Ministry of Rural Development (NIRD), Government of India.

The State Government may kindly extend co-operation to the NIRD team to carry out the pilot Social Audit of MsDP in Kishanganj district. I further request you to kindly appoint a Nodal Officer of appropriate level for effective co-ordination and implementation of the Social Audit Pilot. The Nodal Officer shall coordinate with the NIRD Team to decide the exact location (Village/ Panchayat/ Blocks) and modalities of carrying out the pilot social audit and hence full contact details may be provided to this Ministry.
